- Small Business Jobs Act of 2010 signed 27 Sep 2010, PL 111-240
 - Subtitle C—Small Business Contracting
 - PART I—CONTRACT BUNDLING – Sec. 1311-1341
 - PART II—SUBCONTRACTING INTEGRITY – Sec. 1321-1322
 - PART III—ACQUISITION PROCESS – Sec. 1331-1335
 - PART IV—SMALL BUSINESS SIZE AND STATUS INTEGRITY – Sec. 1341-1347
 - Most of the changes referenced are a result of the Small Business Jobs Act
- National Defense Authorization Act (NDAA) for Fiscal Year 2013, Title XVI – Industrial Base Matters
- Definitions:
 - Open - In development, not published yet.
 - Proposed - Published in Federal Register, no effective date, deadline for comments.
 - Interim - Published in Federal Register, effective date, deadline for comments.
 - Final - Published in Federal Register, effective date, may include changes from interim.
