

**DISTRIBUTION AGREEMENT**  
**OneSAF Product Line Configuration**  
**(For Academia and IR&D Development Activities)**

- **DISTRIBUTION STATEMENT** The OneSAF Product Line Configuration Software and associated materials (together herein, "OneSAF Software") is not authorized for further distribution outside of the requesting organization (hereafter referred to as "Recipient").
- **WARNING** This Distribution Agreement refers to technical data, the export of which is restricted by the Arms Export Control Act (Title 22, U.S.C., Sec 2751, and et seq.) or the Export Administration Act of 1979, as amended, Title 50, U.S.C., and App. 2401 et seq. Violations of these export laws are subject to severe criminal penalties. Disseminate OneSAF Software in accordance with provisions of DoD Directive 5230.25.

SUBJECT TO APPROVAL BY A GOVERNMENT SPONSOR, THE ONESAF SOFTWARE MAY BE USED FOR THE PURPOSE STATED WITH THE FOLLOWING TERMS AND CONDITIONS:

1. The OneSAF Software is Controlled Unclassified Information (CUI) or Export Control under ITAR 22CFR ch1 (4-1-13 Ed) 121.8, and shall be handled and maintained in accordance to DoD 5220.22M -NISPOM, AR 380-5 Information Security Program and the OneSAF Program Protection Plan (PPP).
2. The OneSAF Software shall be used only in accordance with this Distribution Agreement. The purpose may include incorporating the OneSAF Software, or elements thereof, into products being developed under the terms of an Academic Institution Internal Application, a Cooperative Research and Development Agreement (CRADA), an Other Transaction Authority (OTA), or an Independent Research and Development (IR&D) project. The OneSAF Software and data will not be modified, adapted, or otherwise altered except as required for the stated purpose.
3. OneSAF Software shall not be re-distributed, sold, or used for commercial purposes by Recipient, in whole or in part, without the express permission of the Program Executive Office Simulation Training and Instrumentation (PEO STRI) Product Director Next Generation Constructive (PD NGC), OneSAF. Further, the OneSAF Software shall not be released or provided to any organization (including those defined as academic institutions per 26 U.S.C. 501(c)(3)) who is Foreign Owned, Controlled or Influenced (FOCI). The Recipient is prohibited from using the OneSAF open source code for commercial practices and profitable gains. A copy of this Distribution Agreement shall be provided and maintained with each authorized copy of the OneSAF Software and appropriate personnel shall be briefed regarding the Distribution Agreement requirements. Recipient shall be responsible for compliance with this Agreement related to all authorized copies.
4. Recipient shall ensure that all individuals/organizations supporting Recipient return or destroy all OneSAF Software upon completion of the approved work, or completion of the agreement under which the work is authorized, whichever comes first.
5. The OneSAF Software is developmental in nature. The U.S. Government and its agents shall not be liable for any harm, damage, or injury that may result from the use of the OneSAF Software.
6. The controlling DoD office may revoke permission or hereinafter make permission subject to additional conditions as dictated by Government interests.
7. The Recipient or any person acting on behalf of Recipient of the OneSAF Software is a U.S. citizen.
8. Recipient acknowledges its responsibilities under the U.S. export control laws and regulations and agrees that it shall not disseminate any export-controlled material subject to this Agreement in a manner that would violate applicable export controls laws and regulations.
9. The OneSAF Software shall not be sold, released, provided or demonstrated to any Foreign National, or Foreign Representative without prior foreign disclosure approval from the PEO STRI G2, FDO per AR 5-11 – Management of Army Modeling and Simulation and AR 380-10 – Foreign Disclosure and Contract with Foreign Representatives.
10. Unless dissemination is permitted herein and by applicable regulations, Recipient shall not provide access to the OneSAF Software other than to its employees or persons acting on its behalf without permission of the controlling DoD office. Further, Recipient shall provide access to the OneSAF software only to persons who are citizens of the United States.

11. Recipient is not debarred, suspended or otherwise determined ineligible by any agency of the U.S. Government to perform on U.S. Government contracts, has not been convicted of export control law violations, and has not been disqualified under the provisions of DoD Directive 5230.25.
12. Recipient shall not distribute changes to the OneSAF Software source code except as set forth herein without the approval of PD NGC, OneSAF. As consideration for the distribution of the OneSAF Software, the approved Recipient shall provide to the controlling DoD office any and all changes, enhancements, improvements or modifications which may be made to the Product while in the approved Recipient's possession. The changes, enhancements, improvements or modifications made to the OneSAF Software, along with all software source code, shall be provided to the controlling DoD office with Unlimited Rights. The approved Recipient shall send a white paper to the controlling DoD office, at a minimum, on an annual basis. Annual white papers are to be filed no later than January 31 of each calendar year. The white paper shall describe all changes, enhancements, improvements or modifications the Recipient has made to the OneSAF Software. If the white paper or enhancements, improvements, or modifications made to the OneSAF Software are not received by the controlling DoD office with Unlimited Rights, the controlling DoD office retains the right to demand the return and/or destruction of the OneSAF Software in the approved Recipient's possession. Failure to return and/or destroy the OneSAF Software will be deemed a breach of this Distribution Agreement and may result in prosecution of the USG's rights in the applicable forum. Examples of changes, enhancements, improvements, and modifications include, but are not limited to, the following items:
  - a. Creation of new entities, units, or behaviors
  - b. Any modification of existing entities, units, or behaviors
  - c. The modification of existing code
  - d. The creation of new physical models
13. Recipient agrees that prior to publication of any research results arising out of or from the use of the OneSAF Software, the controlling DoD office shall be notified and given the opportunity to review and possibly prohibit said publication if the research results contain information which may adversely affect the national interest.
14. Recipient acknowledges that the OneSAF Software is released under an Assess-only Certificate. In order to operate and maintain the OneSAF Software, the recipient must also acknowledge, agree and adhere to all information security related policies, procedures, controls and limitations in the environment in which the OneSAF Software will be installed. The Government recommends that non-DoD organizations installing the software adhere as close as possible to NIST SP 800-53 for security controls and NIST SP 800-37 which provides guidance in implementing appropriate level Cybersecurity Risk Management Framework (RMF) controls. These controls will need to be addressed as needed by site requirements.
